


Yorkshire & the Humber also struggles, recording 28% of certificates at D–G despite a high volume of over 47k EPCs issued.

A cluster of regions — Wales, Greater London, and West Midlands — all sit at 26%, showing consistent mid-range efficiency concerns.


East of England (24%) and South West / North East (both 23%) demonstrate moderately better outcomes, though still nearly a quarter of homes fall below A–C.

South East (21%) and especially the North West (18%) stand out as the most energy-efficient regions, with far fewer poorly rated homes relative to total issued EPCs.


